New PSR Policy: Students receiving a sacrament must be attending PSR classes at St Henry the prior year and the sacramental year.

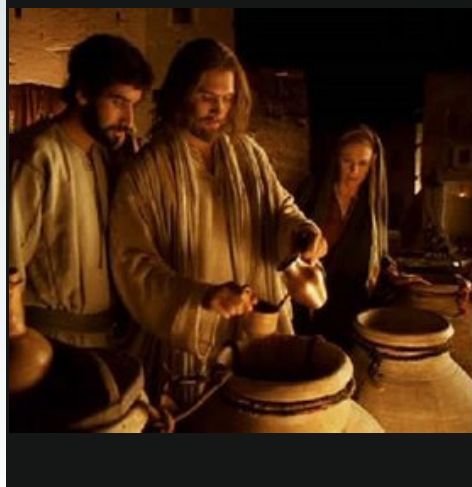
MARRIAGES

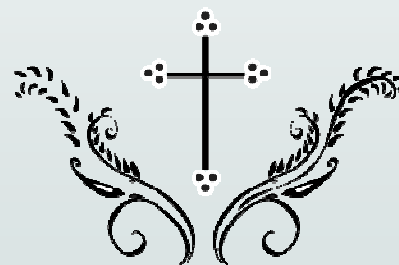

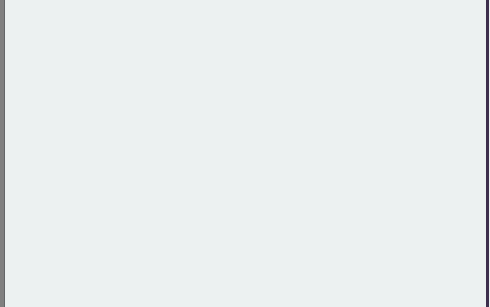

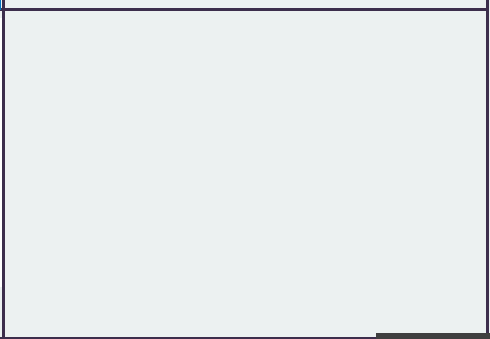
